Overview

The Turkey eVisa is an **electronic authorization** that allows eligible nationals to enter Turkey for tourism, business, and cultural purposes. This PDF details the processes, requirements, and visual representations to help you obtain your visa efficiently.

Types of Visas

- **Turkish eVisa:** Applied online.
- **Sticker Visa:** Obtained via embassy/consulate.

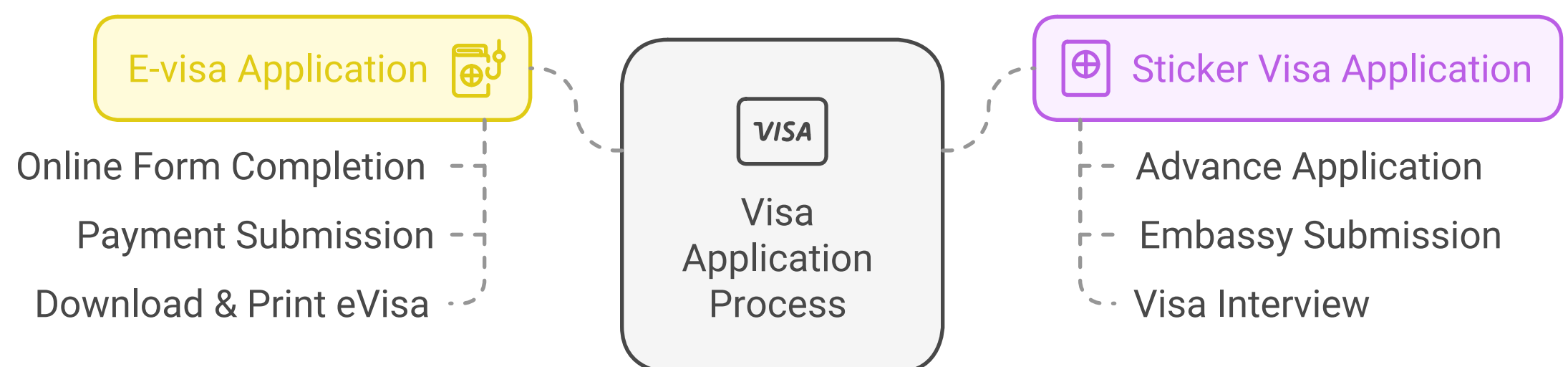
Application Process:

E-visa Application:

- Fill out the form online with personal and travel details.
- Submit the payment using a card.
- Download and print the eVisa for presentation at the port of entry.

Sticker Visa Application:

- Apply 1-2 months in advance.
- Submit at an embassy/authorized center.
- Attend a visa interview if required.



List of Eligible Countries for Turkey eVisa

The following countries are eligible for Turkey eVisa:

Algeria, Antigua and Barbuda, Armenia, Australia, Bahamas, Bangladesh, Barbados, Bermuda, Bhutan, Cambodia, Cape Verde, China, Cyprus, Dominican Republic, Egypt, Equatorial Guinea, Fiji, Grenada, India, Jamaica, Maldives, Mauritius, Mexico, Nepal, Pakistan, Philippines, Saint Lucia, Saint Vincent and the Grenadines, Senegal, Solomon Islands, South Africa, Sri Lanka, Suriname, Taiwan, Vanuatu, Vietnam

Required Documents

E-visa:

- Only **Valid Passport** (minimum 6 months validity)
- The passport should have a minimum of **2 blank pages**.



Sticker Visa:

- Passport (minimum 6 months validity)
- Two recent photographs
- Proof of income (€50/day for expenses)
- Accommodation proof (hotel booking/invitation letter)
- Travel itinerary (flights/tickets)
- Travel insurance (€30,000 minimum coverage)
- Police clearance certificate
- Employment proof.

Processing Times

- **E-visa:** 1-2 days as normal process
- **Sticker Visa:** 15-30 days

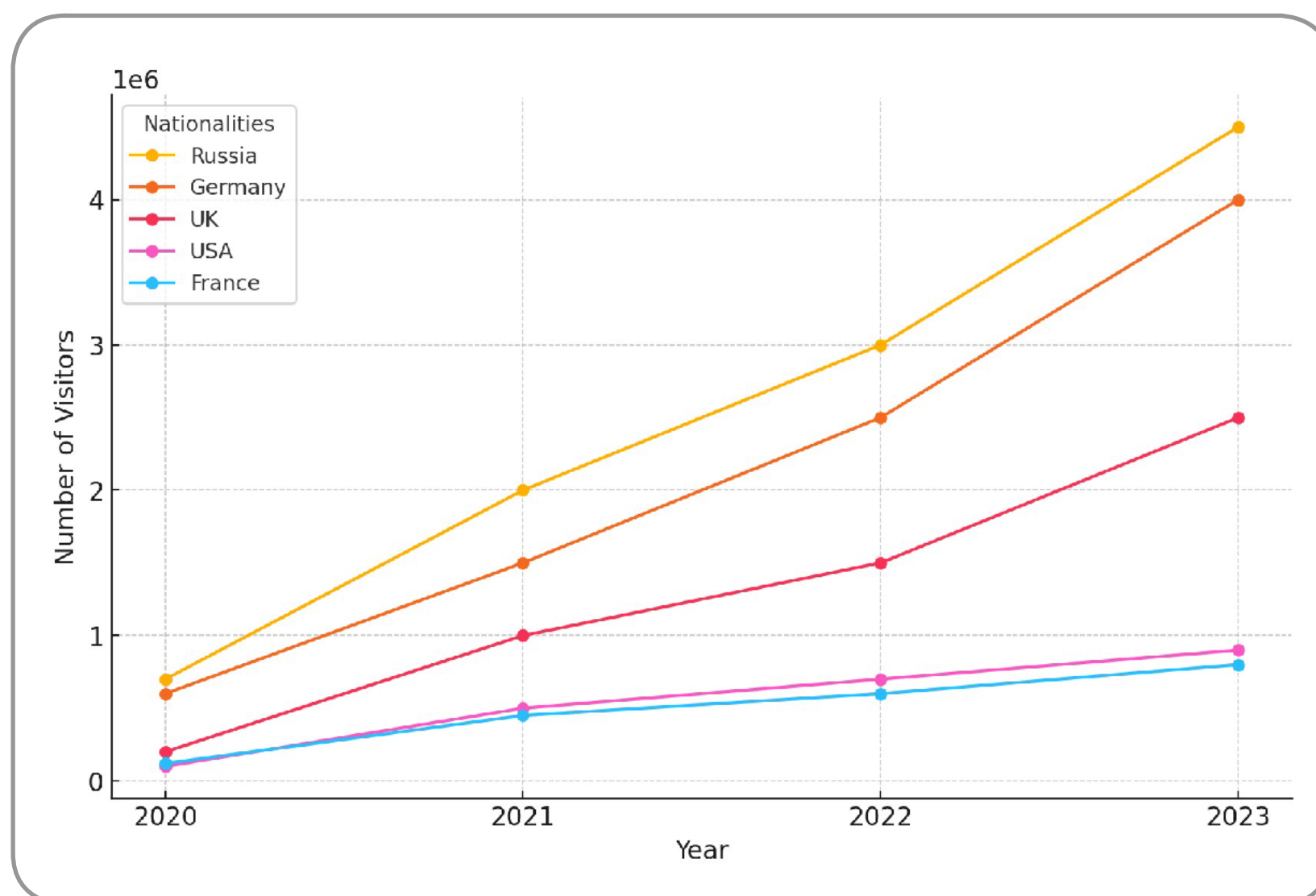

FAQs

What Is the Validity of a Turkey e-Visa?

Most e-Visas for tourism purposes are valid for **180 days** from the date of issue, allowing a stay of up to **90 days** within this period, depending on your nationality.

Q. Are There Any Special Requirements for Group Travelers? Group travelers may need to provide documents from the organizing company, such as itineraries, group details, and confirmation letters.

Q. Much Is the Turkey e-Visa Fee?

Q. Can I Work on a Turkey Tourist Visa?

No, a tourist visa does not permit employment in Turkey. If you plan to work, you must apply for a work visa through the appropriate legal channels.
